## Disclosure of share buybacks in the period from 14<sup>th</sup> to 18<sup>th</sup> March 2022

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative papers for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, as part of the share buyback programme authorized by the Shareholders' Meeting on 13 April 2021, previously disclosed to the market on the same date and on 12 November 2021, in the period from 14<sup>th</sup> to 18<sup>th</sup> March 2022, it purchased no. 6,620 treasury shares at the weighted average price of Euro 3.8085 per share, for a total value of Euro 25,212.20.
