## Disclosure of share buybacks in the period from 21<sup>st</sup> to 25<sup>th</sup> February 2022

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative papers for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, as part of the share buyback programme authorized by the Shareholders' Meeting on 13 April 2021, previously disclosed to the market on the same date and on 12 November 2021, in the period from 21<sup>st</sup> to 25<sup>th</sup> February 2022, it purchased no. 9,386 treasury shares at the weighted average price of Euro 3.9352 per share, for a total value of Euro 36,935.96.

Below, pursuant to Article 2(3) of Delegated Regulation 2016/1052/EU and based on the information provided by the intermediary in charge BPER Banca S.p.A., are the details in aggregate form of the share buybacks made on a daily basis in the period up to 25<sup>th</sup> February 2022 on Euronext Milan (EXM).
