Disclosure of share buybacks in the period from 3rd to 7th October 2022

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative papers for laminated panels and flooring used in interior design, listed on Euronext Milan, organized and managed by Borsa Italiana S.p.A. – Euronext STAR Milan segment, announces that, as part of the share buyback programme authorized by the Shareholders' Meeting on 13 April 2021, previously disclosed to the market on the same date and on 12 November 2021, in the period from 3rd to 7th October 2022, it purchased no. 1,400 treasury shares at the weighted average price of Euro 2.9628 per share, for a total value of Euro 4,147.97.

Below, pursuant to Article 2(3) of Delegated Regulation 2016/1052/EU and based on the information provided by the intermediary in charge BPER Banca S.p.A., are the details in aggregate form of the share buybacks made on a daily basis in the period up to 7th October 2022 on Euronext Milan (EXM).
