

Disclosure pursuant to EU Regulation 2016/679 - Newsletter

This disclosure is provided under Article 13 of EU Regulation 2016/679, which addresses the protection of individuals with regard to the processing of personal data and the free movement of such data (hereinafter also Regulation).

Data Controller: The Data Controller is Neodecortech S.p.A. with registered office in Via Provinciale 2, 24040 Filago (BG).

Purpose and legal foundation for processing: Your personal data are processed to send the newsletter. The legal foundation is consent.

Nature of personal data processed: The Controller shall process basic data, such as, by way of example, identification and contact data (first name, last name, e-mail).

Nature of provision: The provision of data is optional, and in its absence the Controller shall not send the newsletter. Failure to provide data shall not impact any existing contractual relationship with the company. Consent may be withdrawn at any time; however, such withdrawal shall not affect the lawfulness of the processing based on the consent provided prior to its withdrawal.

Processing procedures: The processing of personal data shall be conducted mainly in an automated manner, through security measures to ensure the protection and utmost confidentiality of the data. The processing shall abide by the principles of fairness, lawfulness, and transparency, safeguarding your privacy and rights.

Recipients of personal data: The personal data collected may be processed within the Data Controller's organization by authorized and trained individuals. The data may be disclosed to third-party companies assisting the Data Controller in managing marketing communication activities as Data Processors, and to subjects authorized to access personal data by law and/or regulatory provisions.

Dissemination or transfer of data outside the European Union: The data shall not be disseminated and shall not as a rule be transferred outside the European Union. Any transfer of data outside the European Union shall occur solely to subjects ensuring an appropriate level of processing protection and/or to countries approved by competent authorities for their adequacy. Moreover, transfers shall occur to subjects offering suitable processing guarantees through regulatory/contractual means, such as the signing of standard contractual clauses.

Data retention: The personal data shall be retained only as long as necessary for the intended purposes and, in any event, until consent for the newsletter distribution is withdrawn.

Data subject's rights: Lastly, the data subject may request information about their personal data by writing to the e-mail address privacy@neodecortech.it. Specifically, the data subject may:

- access their personal data, receiving details of the purposes pursued by the Controller, the categories of data involved, the recipients to whom the data may be disclosed, the applicable retention period, the existence of automated decision-making processes, including profiling, and, at least in such cases, relevant details on the underlying logic, as well as the significance and potential implications for the data subject, if not already specified in this Disclosure;
- promptly obtain the rectification of inaccurate personal data concerning them;
- obtain, in the cases provided for by law, the deletion of their data;
- obtain the restriction of the processing or to object to their processing, if permitted under the provisions of the law applicable to the specific case.
- If you deem it appropriate, you may file a complaint with the Supervisory Authority.
