Disclosure of share buybacks in the period from 27th November to 01st December 2023

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, as part of the share buyback programme authorized by the Shareholders' Meeting on 27 April 2023, previously disclosed to the market on the same date and on 15 May 2023, in the period from 27th November to 01st December 2023, it purchased no. 7,500 treasury shares at the weighted average price of Euro 2.8813 per share, for a total value of Euro 21,610.00
