### Disclosure of share buybacks in the period from 21<sup>st</sup> to 25<sup>th</sup> July 2025

Neodecortech S.p.A. ("NDT" or the "Company"), one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed in the Euronext STAR Milan ("STAR") segment organized and managed by Borsa Italiana S.p.A., announces that, in the period from 21<sup>st</sup> to 25<sup>th</sup> July 2025, it purchased no. 4,500 treasury shares at the weighted average price of Euro 2.9026 per share, for a total value of Euro 13,061.80
