Neodecortech S.p.A., one of Europe's top players in the production of decorative surfaces for laminated panels and flooring used in interior design, listed on Euronext Milan, organized and managed by Borsa Italiana S.p.A. - Euronext STAR Milan Segment, announces that it has been selected among the 100 listed companies comprising the **Intermonte Valore Italia Index**, dedicated to small and mid-cap companies with a market capitalisation below €1 billion and not included in the FTSE MIB Index.

Companies are selected according to rigorous technical and financial criteria designed to ensure adequate levels of liquidity, transparency and investability. These include a minimum free float, strong corporate governance standards, analyst coverage, financial sustainability and leverage levels, as well as appropriate representation within the Index itself.

The Index, which is part of PMI2Change, Banca Generali's innovative initiative aimed at supporting the growth and competitiveness of Italian entrepreneurs by fostering the development of Italy's listed SMEs, provides a genuine snapshot of the country's leading areas of expertise. It also helps broaden and diversify investment opportunities beyond traditional market indices for both domestic and international investors.

Luigi Cologni, CEO of Neodecortech S.p.A., commented: *"Being included among this group of Italian excellence is further recognition of our growth and of the effectiveness of the work carried out in recent years to strengthen the Group's positioning in the capital markets. We are proud to have been included in an initiative of this calibre, which offers us the opportunity to further enhance our visibility among investors and broaden the range of financial stakeholders interested in our industrial project. This recognition encourages us to continue pursuing our growth strategy, with the objective of creating sustainable value for all our stakeholders."*

Building on the Index, Banca Generali, together with Investlinx and Intermonte, has launched a new actively managed, PIR-compliant ETF that will invest primarily in the universe of companies represented by the Index. Banca Generali has committed to supporting the launch of the fund with an initial fundraising target of €100 million during its first few months, with a gradual increase in assets under management to reach €500 million over the medium term.
